

ASBA Calls for Entries

October 27 – 29, 2011

“Small Works” 2011 ASBA Conference Exhibition
Boston Marriott Newton, Massachusetts

Each registered attendee at the Conference may enter one “Small Work” for exhibition during the conference. The exhibition will be open to the public. Artists will take their artwork home at the close of the conference on Saturday evening. Original packing material will not be available for taking the artwork home.

Eligibility: Any registered attendee at the 2011 ASBA conference

Jurors: This exhibition is non-juried.

Subject: Any botanical subject.

Medium: Any two-dimensional original medium.

Image size limitation: The maximum outside of the frame must be no larger than 9” in one dimension along outside edge and no larger than 12” in the other dimension along outside edge.
i.e. **Maximum outside dimensions of frame are 9”x12” – no exceptions –**

Number of submissions: One

Small Works Entry Deadline and Catalog Art Submission Deadline: August 1, 2011

Entry information must include: Botanical name, common name (if you wish), medium and artist’s name and contact information. This same information must be on the back of the “Small Work,” lower left hand corner. **Send information to: smallworks2011@nesbaartists.org**

Catalog Art Submission Information: There will be a print-on-demand catalog to pre-order with your conference registration and pick up at the conference. To have your Small Works included in this catalog:

Submit digital file of your image – **300 dpi, image 8"high, jpeg ONLY** – on CD labeled with artist's name and name(s) of artwork(s) in marker, no paper labels. Individual files on disk labeled with artwork title, size, and medium. CD will not be returned.

Presentation: L-profile “gallery” frame medium to light brown wood frame or gold wood (per ASBA standards) with white or off-white mat, Plexiglas glazing, wired for hanging.
Works not meeting these standards will not be hung.

Artwork Delivery: All entries – **no exceptions** – must fit and be packed securely in a **FedEx or U.S. Postal Service Priority Mail Box with tracking** as described below (approximately 13 x 11.5 x 2.3 inches) and must be shipped via 2-dayservice or a US Postal Service Priority Mail.

Shipped to arrive between **Monday, October 10** and **Friday, October 14, 2011**. Works bubble wrapped only, no Styrofoam peanuts. Works packed in peanuts will not be opened or hung. Shipping materials will not be retained.

Internal measurements: Height 29.2cm, Width 33cm, Depth 6cm.

US Postal Service Medium Flat Rate Priority Mail Box



Size: 13 5/8" x 11 7/8" x 3 3/8"

MUST add tracking, delivery confirmation, and/or insurance.

Awards: A panel of jurors will give awards to selected artwork, and members will vote for a Members’ Choice Award.
